

# OhioLINK is a consortium that efficiently manages the state's scholarly resources.

OhioLINK negotiates on behalf of 120 higher education libraries throughout the state, plus the State Library of Ohio, giving aggregated purchasing power to Ohio's academic libraries. OhioLINK, the state's most viable cost-saving mechanism for academic libraries today, serves nearly 600,000 students and faculty. Since 1992, OhioLINK has brought valuable resources to libraries at the lowest possible cost.

Supporting Ohio's Knowledge-based Economy OhioLINK's traditional user base includes students, faculty, and staff at all of Ohio's public and private universities and community and technical colleges. But OhioLINK's funding reach goes far beyond Ohio's academic institutions. For 20 years, OhioLINK has used its superior negotiating position to help P-20 learners across the state access education-based resources.

OhioLINK contributes a significant share of the cost of the databases that make up Libraries Connect Ohio, which supports "continuous life-long learning." This provides a common set of resources available to Ohioans throughout their educational, work, and personal lives via academic, school, and public library support.

High school students who participate in the College Credit Plus program get a head start on college preparation by access to all OhioLINK resources in all subject areas. Non-traditional students, whether they are re-training for new jobs or adding the newest knowledge to their existing skills, have access to an unbelievably broad range of resources at every OhioLINK institution.

Now and into the future, OhioLINK must invest wisely in shared content. Our consortia of 121 member libraries is increasingly relying upon the content and services that OhioLINK provides.

## **Maximizing Return on Investment**

#### **Cooperative Funding**

Capital funding from the Board of Regents subsidizes the cost of the high-quality electronic journal content that OhioLINK institutions rely upon for research and teaching. This central OhioLINK funding covers only 17 percent of the annual total spent for OhioLINK electronic resources – the remaining 83 percent comes from OhioLINK member institutions. The central funding directly benefits member institutions by enabling the continued purchase of STEMM content in the most cost-effective way, and making it widely available to the largest possible number of Ohio faculty, students and staff.

#### **Collective Buying Power**

OhioLINK traditionally does much better at negotiating for reduced pricing than individual institutions or other national and international library consortia. We leverage the collective buying power of the members and use central state funding to incentivize vendors to maintain state-wide access to all 121 OhioLINK member libraries, public and private, at an affordable cost. This approach offers significant savings; in the case of one subscription, OhioLINK institutions collectively saved six million dollars over the cost of negotiating individually. Keeping OhioLINK packages intact is the most efficient method of acquiring and disseminating content that supports academic research and teaching in Ohio.
